Reports:

Climate Smart Communities Update: Nancy said there have not been general meetings although there have been subcommittee meetings. Kelsey said they are getting all the actions in the portal to reapply for bronze certification in January. Certification expires after 5 years and Dutchess's certification will expire. The intention is to apply for silver certification in July when some of the projects such as the GHG inventory and Climate Action Plan are complete.

Fishkill Creek Watershed Alliance: Jim informed the group that the alliance is still working on organizing. The watershed workshop took place at the Farm & Home Center December 5, 2023 and was attended by members of all watershed groups in the County.

Solid Waste Management: The group discussed the new Solid Waste Management Plan. Vicky will start the discussion with a list of the items that resonated and a potential to do list.

Natural Resource Inventory: Kelsey updated the group that the NRI will be completed by the end of December 2023.

Road Salt: The Red Hook town board expressed interest in a presentation about road salt and information about brine. Vicky can do a presentation about the environmental effects and Bob Wyant, Rhinebeck's highway superintendent is willing to talk about his brine operation. Vicky is in conversation with Riverkeeper about road salt advocacy.

Peach Hill Green Infrastructure Project: No new updates.
